TEMPLATE 6: Creating the Pitch

Our recent report, **Brivo Smart Security Trends Report**, highlights the importance of an integrated security ecosystem, especially for enterprise organizations. To bring your employees back with confidence, the building itself must function in a healthy way and cloud access control is an integral technology to implement social distancing, health screening and to control traffic flow within the building.

On the integration front, a different **Forbes article** pointed out, **"For businesses, supply chain visibility, security and pedigree are the new transformation imperatives.** Thomas Vollman's 1996 book, The Transformation Imperative, focused on how highly integrated corporations can adapt to weather not just competitive challenges, but also unexpected market changes like what we are experiencing now [COVID]. Companies either gain competitive advantage, or they are victims of competitive parity. Sadly, North America leans to the latter, with a vast array of sub-par systems and parts embedded in some of the most sensitive systems (including intelligence and defense)."

Spell out the benefits of adding cloud access control into the techstack of the organization. The critical data provided by an enterprise cloud access control solution can be used now to keep returning employees safe and healthy and in the future to plan for office space usage and to create a cohesive and convenient user experience across an entire portfolio of buildings.

ROI:

No pitch would be complete without projected financial benefits (ROI). As we all know, money talks. You can calculate the **ROI of moving your physical security** to the cloud here. Include a clear and defensible calculation that looks at the total cost of ownership including not just hardware, software and maintenance but also staffing time, salaries, overtime etc.
